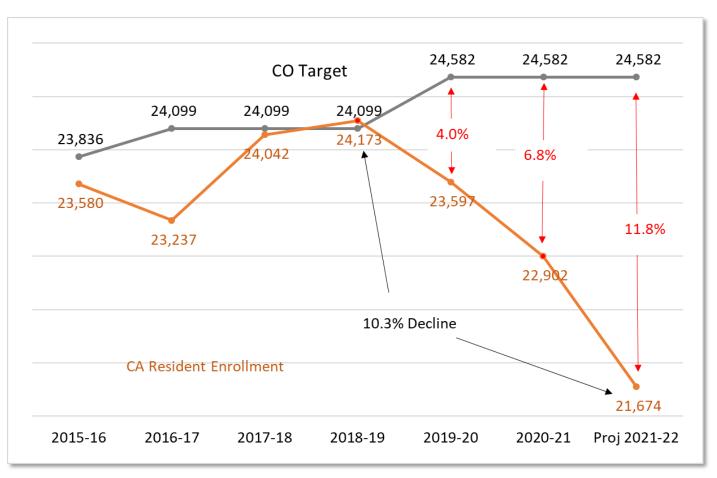

First-year retention for Fall 2020 first-time freshmen improved 2.5% from the previous year (from 79.9% to 82.4%). Slightly declined for new undergraduate transfers 1.7% (from 88.8% to 87.1%)

CA Resident Enrollment (FTES)

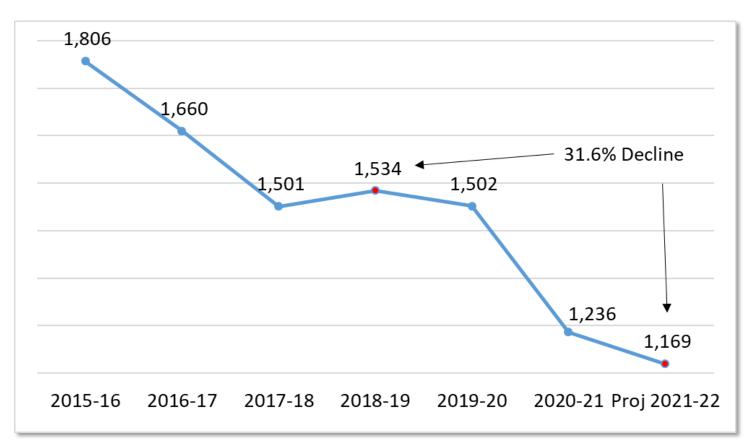

- ➤ Based on the preliminary CY 2021-22, we will come about 11.8% below the CO assigned target.
- For the last 3 years (between 2018-2019 and 2021-2022), CA resident enrollment (FTEs) had declined 10.3%

- CO Target = Chancellor's Office assigned target for CA residents
- FTES = Full-time Equivalent Students: 1 FTES = 15 credits per semester for undergrads and 12 for graduates

Non- CA Resident Enrollment (FTES)

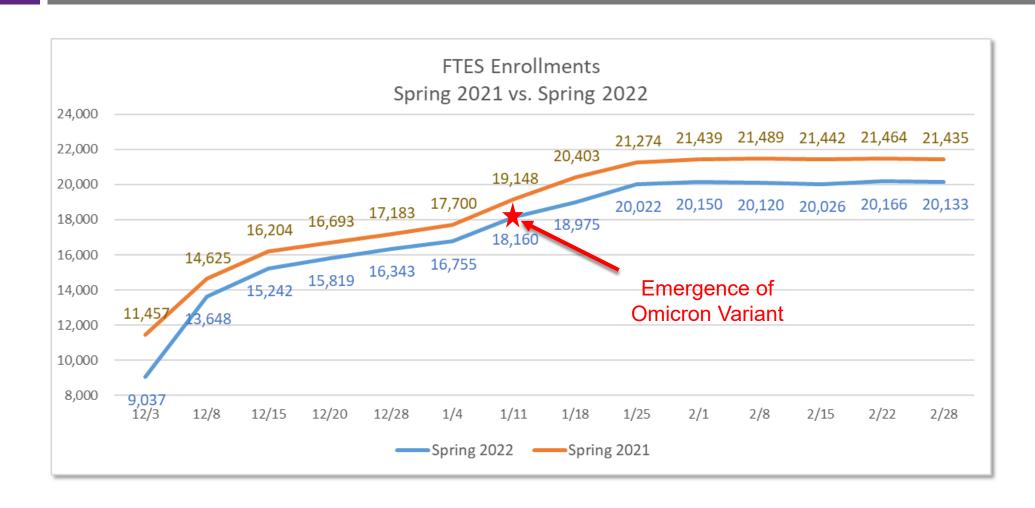

- Non-resident enrollment continued to decline (5 out of last 6 years).
- Significant declined 17.7% last year alone and 4.4% this year.
- For the last 3 years (between 2018-2019 and 2021-2022), non-resident enrollment (FTEs) had declined 31.6%

Take Away

Undergraduates:

- Incoming undergraduates flat to last year but largely due to freshman starting in the spring
- Continuing undergraduates dropped significantly due to
 - lower retention rates for juniors and seniors
 - declined in first-time freshmen and new UG transfers (3 out of last 4 years)

Graduates:

Declined in new and continuing graduates since the pandemic began in 2020

CA Residents:

- For the last 3 years, CA resident FTEs had declined 10.3%
- Will come about 11.8% below the CO assigned target.
- Spring 2022 projection had been on track for 10% below the CO target until Omicron variant disrupted at the beginning of January 2022.

Non-residents (Outside CA students + Internationals):

- Non-resident enrollment continued to decline (5 out of last 6 years)
- For the last 3 years, non-resident FTEs had declined 31.6%

Incoming Undergraduate Students

Immediate:

- Fall 2022 Undergraduate Accepted Admission Offers are lagging behind last year
- Admitted Student Packets, Digital Marketing Retargeting, Early Financial Aid Offers, in-person/virtual events
- Sign up to help in the effort to strengthen our incoming class
 - Help out on April 9, 2022 for our Explore SF State Admitted Student Day
 - Join our calling campaign to admitted students!

In the Works:

- Brand/Enrollment Marketing Campaign development and roll out in May to increase applications
- Partnerships with high schools and community colleges to streamline data sharing and increase applications
- Improved admissions communication plan to speak more directly to students and families at each stage of the enrollment process
- Renewed recruitment strategy focused on maximizing our impact per visit
- Streamlined processes within our student information system to reduce administrative barriers to students

Future:

- Enrollment focused website redesign (RFP ends late Fall 2022; work starts 2023)
- Maximizing the use of our CRM to track & engage students and families earlier in the enrollment pipeline
- Improved scholarship leveraging to increase student likeliness to attend

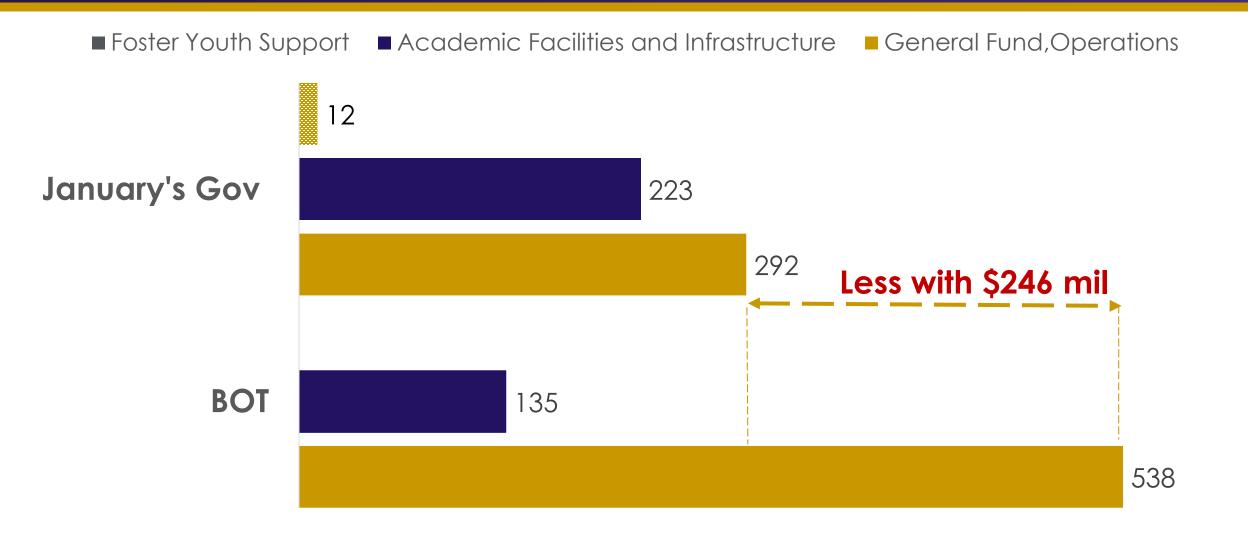

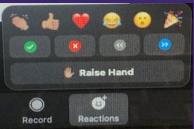
